

Best Practices in Carbon Accounting

Pressure for defensible carbon metrics is coming from investors and policy makers to comply with global environmental goals and protect against greenwashing.

POLICY REQUIREMENTS

CSRD: European Reporting Mandates

- Businesses with \$150 million+ per year revenue in the EU are required to comply
- · Detailed Scope 1, 2, & 3 GHG emissions data
- · Documented 1.5°C reduction strategy
- Metrics beyond carbon: double materiality, ESG progress, and more
- Staggered start for companies based on revenue amount

SEC: Proposed US Reporting Mandates

- Applies to all publicly-traded US companies and non-US companies with US-traded shares
- Detailed Scope 1 & 2 GHG emissions data (Scope 3 may not be included)
- Framework modeled off the Taskforce for Climate-related Financial Disclosures (TCFD)
- First filings scheduled for 2024 financial reports, including 2023 data

STEPS TO CARBON ACCOUNTING SUCCESS



Strategize

Understanding who you're reporting to helps drive your process, framework choices, and data collection approach.



Determine Organizational Boundaries

Boundaries are broken into three scopes based on control. You can evaluate these boundaries based on equity, operational, or financial control.



Collect & Consolidate Data


Data may be disparate or incomplete, so it's important you use an IQMS to organize and track data sources, quality, and gaps.



Organize & Report

Carbon data can be reported publicly to CDP, M2030, EcoVadis, etc., and used to set baselines for reduction.

- · Invest in energy management software
